



International Product Warranty

- With effect from January 1st, 2022, PowaKaddy International Limited and its subsidiary companies ('PowaKaddy') of Castle Road, Sittingbourne, Kent, ME10 3RN provides to the purchaser of any new PowaKaddy product (the 'product') purchased from an authorised retailer in your country of residence, a Manufacturer's Limited Warranty against inherent defects for the period, and on the exclusions and conditions, set out hereafter:

- The Warranty is subject to the following exclusions:
 - Accidental damage, customer misuse or neglect.
 - Fair wear and tear.
 - The use of a non-rental electric trolley in a rental or other commercial application.
 - Unauthorised modification to the Product.
 - Faulty repairs by consumer or unauthorised agent.
 - Failure to follow battery charging instructions, including leaving a battery in a discharged state for prolonged periods.
 - The removal or defacing of serial numbers on the product will invalidate the warranty
 - The Standard 30V Lithium Battery is designed for use over 18 holes and must always be fully charged before the next round. We are aware that some golfers will try to stretch these batteries to 27 holes. This may damage the overall capacity of the battery and may result in an early failure. Playing more than 18 holes with a Standard Battery can seriously shorten the battery's life and will invalidate the battery's warranty.
 - In normal conditions the XL Extended 30V Lithium Battery will do 36 holes when used on a Powakaddy product. Conditions such as long or exceptionally hilly courses, wet ground conditions and excessively heavy golf bags will reduce the range of the battery.
 - The XL Plus 30V Lithium Battery is designed to be used with the RX Series of Electric Golf trolleys and should be considered an 18- hole battery when used in that context. When used with other compatible PowaKaddy Electric trolleys, you will see an extended range of up to 36-holes.
 - The following conditions apply:
 - PowaKaddy's Standard warranty scheme covers manufacturing defects that occur through normal use on an Electric Trolley. Any breakage caused by accidental damage or as a result of abuse and misuse or commercial use is not covered.
 - Under this scheme, PowaKaddy will, at its own option, repair or replace the defective product or part free of charge.
 - This warranty is in addition to and does not affect the consumer's statutory rights. Further information in respect of these statutory rights can be obtained from your local Trading Standards Department, Citizen's Advice Bureau or Consumer Centre.

- PowaKaddy reserves the right to inspect or test any Product claimed to be defective.
 - The period of warranty commences on the date of purchase of the Product. Proof of purchase and purchase date may be required. Any repairs or replacements made without charge do not carry a new warranty beyond that of the original purchase.
 - Warranty registration within 30 days of purchase of an Electric Golf Trolley or Battery is required to ensure any claim can be processed promptly, without need for further proof of purchase.
 - Warranty registration within 30 days of purchase of a CT6, CT6 GPS, CT8 GPS, FX7, FX7 GPS, RX1, RX1 GPS electric trolley model is mandatory to qualify for the full "3-Year Frame Warranty programme". Unregistered product will have a standard 2 Year warranty.
 - Warranty registration within 30 days of purchase of a Plug 'n' Play Battery™ is mandatory to qualify for the "5-Year Pro-Rata Warranty" programme. Unregistered lithium batteries will have a standard 2-year warranty. If your battery should fail before the end of the second year of ownership, PowaKaddy will offer you a brand-new replacement free of charge. In year 3, a brand-new replacement can be purchased for a 50% discount off the recommended retail price, in year 4, for a 30% discount off the recommended retail price and in year 5 a 15% discount off the recommended retail price. This transaction will incur a postage charge and must be transacted directly with PowaKaddy or PowaKaddy's authorised representative.
 - The warranty is non-transferable.
